Results of 2023 Annual General Meeting – Proxy Voting Percentage Correction

Qantas Airways Limited (Qantas) attaches a revised version of the results of the resolutions put to the Qantas Annual General Meeting held on 3 November 2023.

An error was identified with the previously stated percentages relating to the proxy voting results, all other figures were correct.

All resolutions were decided by way of poll and were passed as ordinary resolutions, with the exception of Resolution 4 which was not passed.

As more than 25% of the votes cast on Resolution 4 were against the adoption of the 2023 Remuneration Report, this constitutes a 'first strike' for the purposes of the Corporations Act 2001 (Cth).
